### **CMGP GROUP, A LEADING PLAYER IN AGRI-EQUIPMENT AND AGRI-INPUTS, STRENGTHENS ITS PRESENCE WITH THE ACQUISITION OF COMPAGNIE DE PRODUITS CHIMIQUES DU MAROC (CPCM)**

CMGP Group announces the signing of an agreement to acquire 92.5% of the share capital of Compagnie de Produits Chimiques du Maroc (CPCM) from its historical shareholders, ABC Holding and Mr. Khalid Lahlou, with the objective of increasing its stake to 100% over time.

The transaction values CPCM at nearly 1 Bn MAD, marking a key milestone in the execution of CMGP Group's strategic roadmap.

This acquisition is fully aligned with CMGP Group's external growth strategy, which began with the acquisition of CAS in 2021 and was further reinforced in 2024 with the investment in Agrosem. The combined offering will allow both entities to better serve farmers and clients through a broader, more integrated and accessible portfolio of solutions that addresses today's challenges in agronomic performance, sustainability, and competitiveness.

Through the integration of CPCM, CMGP Group is accelerating its development in the crop protection market, while also significantly expanding its product portfolio to include chemical solutions for water treatment and a range of industrial applications (paper, cardboard, paint, etc.).

CPCM's revenue for 2025 is expected to reach 500 M MAD, bringing the Group's consolidated revenue close to 3 Bn MAD on a pre-synergy basis.

The combination of CMGP Group's and CPCM's complementary expertise will generate strong industrial and commercial synergies, including export opportunities. This acquisition further strengthens CMGP Group's integrated, resilient, and multi-sectoral model by unlocking new growth levers beyond the agricultural sector.

The completion of the transaction remains subject to customary conditions precedent, including approval from the Moroccan Competition Council.
